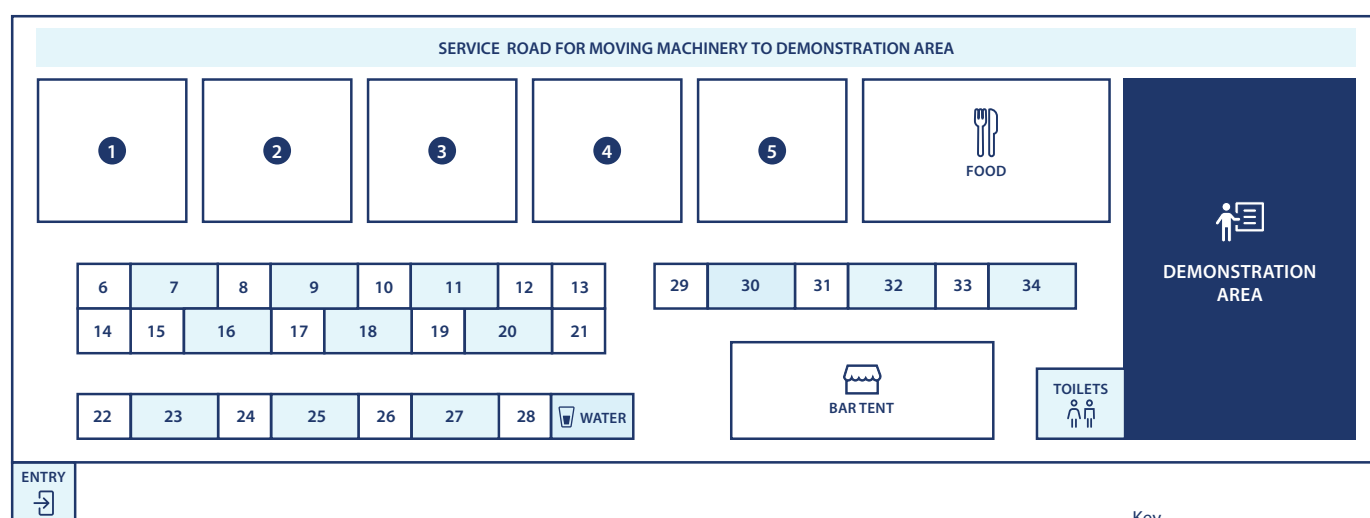
# Exhibiting at Turf Days™.




Turf Days provides an opportunity not seen before in the New Zealand turf industry. Located outdoors in a large allocated space at the Kimihia Research Centre, exhibiting companies can choose to utilise large, medium and small sites to demonstrate their machinery and other products.

The exhibition area provides space for up to 34 exhibitors, with a designated service road and demonstration area for large machinery to be seen in action by attendees. Power and water connections are available while food vendors will be available for attendees as they move around the trade sites.

Toilets will be within close reach and a large outdoor marquee and bar provide spaces for presentations and shelter from the sun.

HireKING have been enlisted to provide exhibitors with their onsite needs including temporary structures, furniture and accessories. The site map below outlines the current layout plan and site options; **we recommend securing your site early to ensure you receive your preferred location.**

# Terms and Conditions

1. In these terms and in all event material:
  - *Event* means the Organiser's Turf Days event planned to be held on Wednesday 6<sup>th</sup> April to Thursday 7<sup>th</sup> April 2022
  - *Exhibitor* includes all advisers, agents, contractors and employees of the Exhibitor
  - *Organiser* means PGG Wrightson Seeds Limited
  - *Site* means the site on which the Event is being held
  - *Space* means the space on the Site allocated by the Organiser to the Exhibitor to occupy and use during the Event.
2. The Exhibitor shall pay to the Organiser the amounts provided for in its application for a Space when due in accordance with the application. In the event the Exhibitor does not pay any amount when due the Organiser may terminate the Exhibitor's right to occupy and use the Space and retain all amounts already paid by the Exhibitor.
3. The allotment of Space by the Organiser to the Exhibitor shall constitute a licence and not a lease.
4. The Exhibitor may use at its discretion any promotional material in relation to the Event provided to it by the Organiser for that purpose.
5. The Exhibitor may erect a marquee/tent, awning and display structures on the Space. All pegs, spikes and other protruding objects must be covered with bags or screened by shrubs.
6. Before digging any holes or driving any objects into the ground on the Space the Exhibitor must ensure that there are no underground cables or pipes in the location of the proposed hole or object identified by the Organiser. If the Exhibitor causes any damage to underground cables or pipes that were identified by the Organiser the Exhibitor shall meet all costs of repairing that damage.
7. If the Exhibitor has a marquee/tent, awning or display structure on the Space the Exhibitor must also have adequate and suitable fire extinguishers readily available on the Space.
8. The Organiser shall arrange night security at the Site commencing at 6pm on the Tuesday before, and ending at 8am on the Friday after the Event.
9. The Exhibitor shall comply with all statutory obligations in relation to its actions on the Site including by the following:
  - The Exhibitor shall comply with its obligations under the Health and Safety at Work Act 2015. The Exhibitor shall identify all hazards to health and safety and eliminate, and if it is not possible to eliminate then mitigate, those hazards so far as is reasonably practicable. When on the Site the Exhibitor shall, and shall ensure its invitees on the Space, comply with all of the Organiser's health and safety related policies and directions advised to the Exhibitor.
  - The Exhibitor must comply with all obligations in relation to the erection and use of any marquee/tent, awning or display structure, the display and/or sale of machinery, vehicles and/or other products or goods or services, and all aviation safety obligations.
10. If the Exhibitor allows persons to examine, move or operate any item on the Space the Exhibitor shall ensure those activities cannot and do not cause harm to any person.



11. The Exhibitor may only bring dangerous goods onto the Site in accordance with the prior written approval of the Organiser. The Exhibitor shall comply with all statutory obligations in relation to the handling and use of the dangerous goods.
12. The Exhibitor may not sub-licence, on-sell or share the Space to or with any other person.
13. The Exhibitor shall remove all of the things it brought onto the Site and make good all damage to the Space, including filling holes, by 5.00pm on the second day after the Event finishes. Anything not removed from the Site by the Exhibitor may be removed and disposed of by the Organiser as the Organiser determines. Any repair not completed by the Exhibitor may be undertaken by the Organiser as the Organiser determines. All costs incurred by the Organiser shall be reimbursed by the Exhibitor.
14. If the Exhibitor cancels its booking to attend the Event:
  - more than 60 days prior to the Event the Organiser may refund part or all of any amount already paid by the Exhibitor as the Organiser determines; and
  - within 60 days prior to the Event the Organiser shall retain any amount already paid by the Exhibitor.
15. If anything occurs, or may occur, which in the opinion of the Organiser (acting reasonably) justifies the cancellation or postponement of the Event the Organiser has the right to cancel or to postpone the Event by notice in writing (or orally in the case of emergency). The Exhibitor has no right to the return of any amount paid by the Exhibitor or to any compensation or payment arising from or in relation to any cancellation or postponement. Any cancellation or postponement shall not affect the Exhibitor's obligation to pay any amount due before the cancellation or postponement.
16. The Exhibitor indemnifies the Organiser, and will keep the Organiser indemnified, for any costs the Organiser incurs and any loss the Organiser suffers that is caused or contributed to by any act or omission of the Exhibitor at or arising from or in relation to the Event whether or not the act or omission constitutes a breach of these terms.
17. The Organiser has no liability for any loss of, or damage to, any property of the Exhibitor or of its invitees however caused, and whether or not caused or contributed to by any act or omission (including any negligent act or omission) of the Organiser or any adviser, agent, contractor or employee of the Organiser.
18. The Exhibitor should arrange appropriate insurance for its property and any consequences of the postponement or cancellation of the Event.
19. The Organiser shall be under no liability for the loss of or damage to Exhibitor's or other property of the Exhibitor, or of its servants, agents, invitees or licensees howsoever such loss or damage may be caused, and whether or not caused in whole or in part by the negligence or other actions of the Organiser, its servants or agents. The Exhibitor is advised to take out all necessary insurance.
